Beginning with the Company's successful acquisition of the "Mobile Offshore Production Unit (MOPU) Conversion and Operating Services" project in 2006, it sparked renewed interest in pursuing a business line that supports Offshore Production Facilities activities.

After that, it was later supplemented by Marine Service, with the primary focus on providing ships to support oil and gas production activities in shallow sea waters. Currently it is complemented with Construction business to support client's needs.

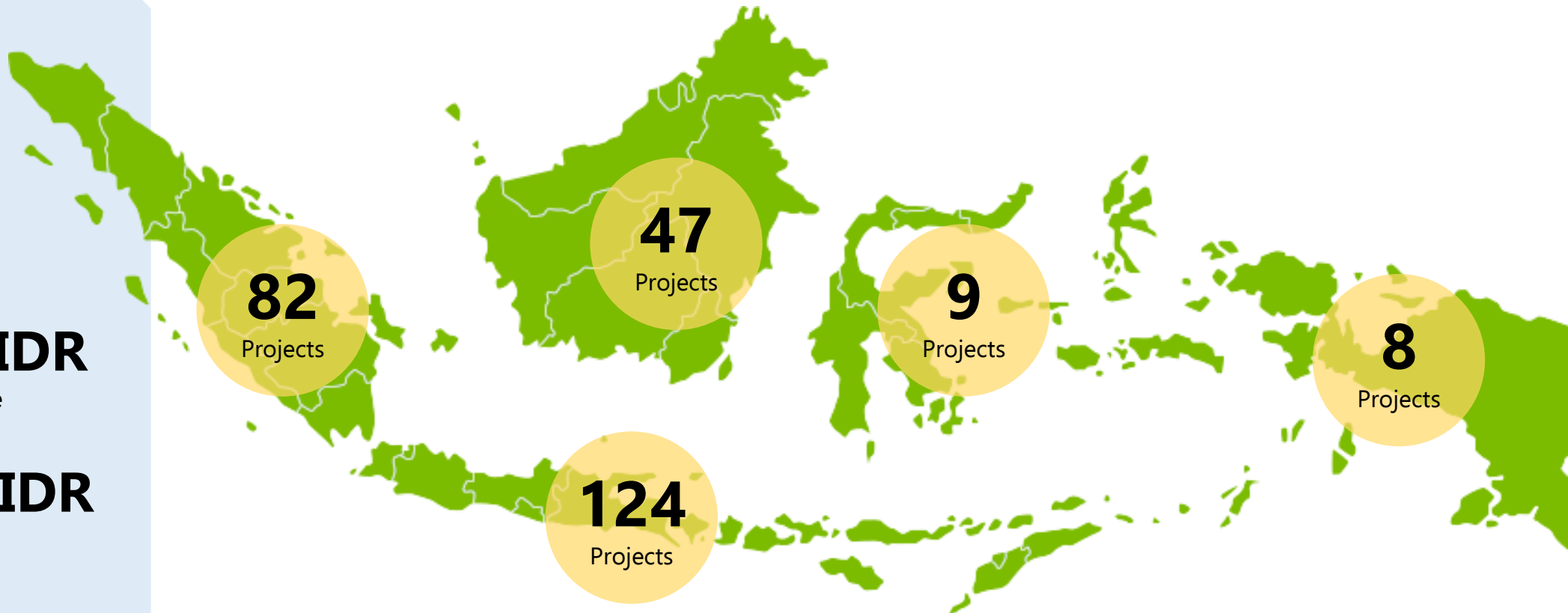



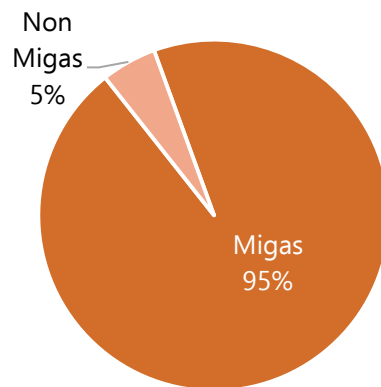

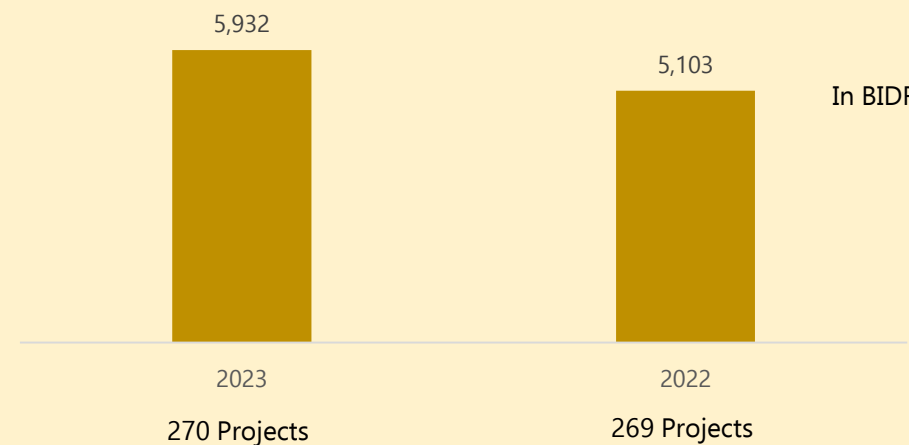

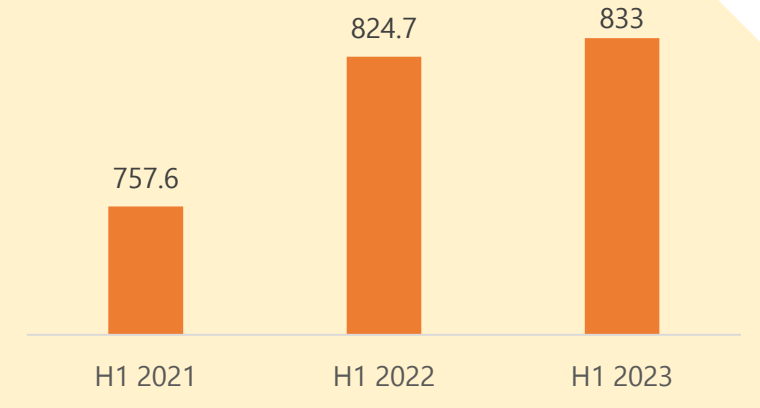


- Increase in new-win and on-hand projects may not instantly impact to the bottom line current performance;

- Contract utilization tends to increase inline with the increase in activity of business in oil and gas

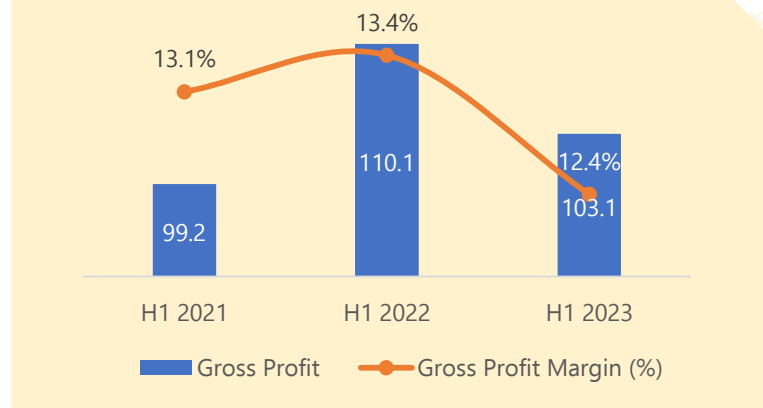

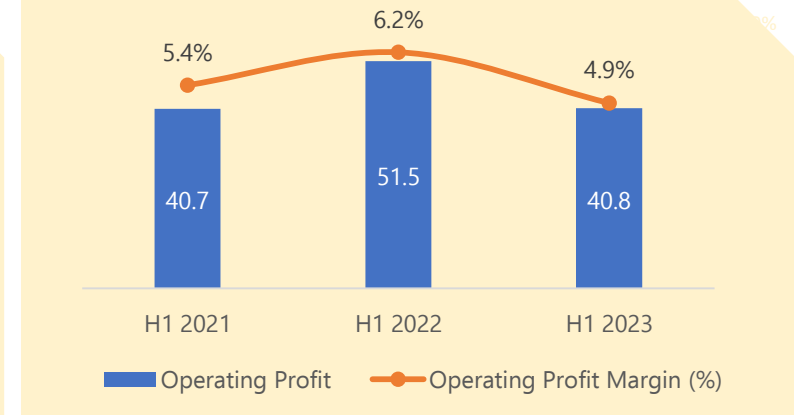
Revenue



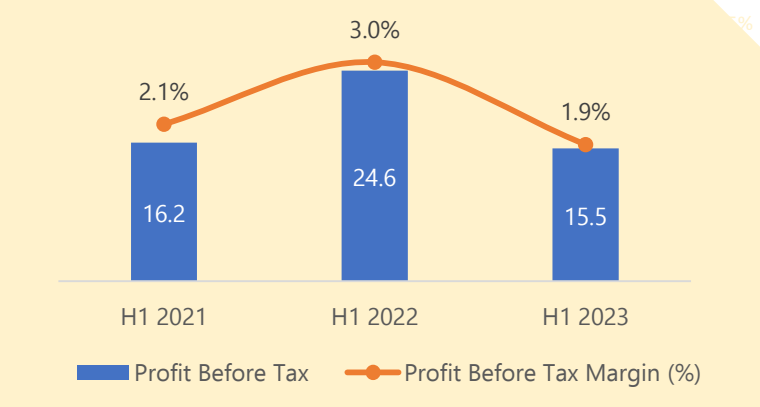
Gross Profit & Margin



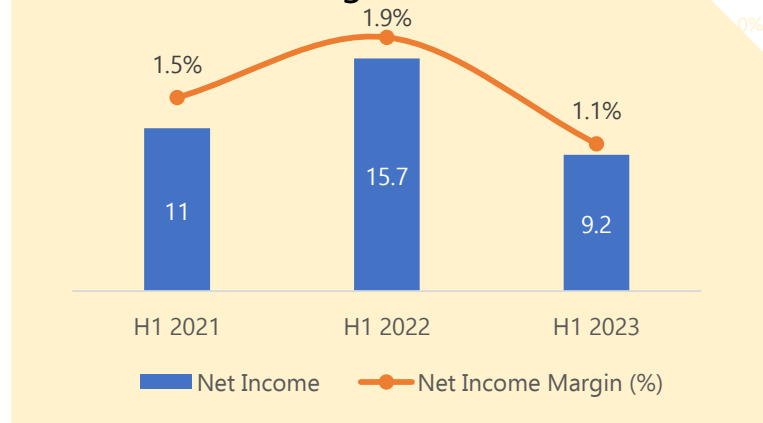
Operating Profit & Margin

Net Income & Margin



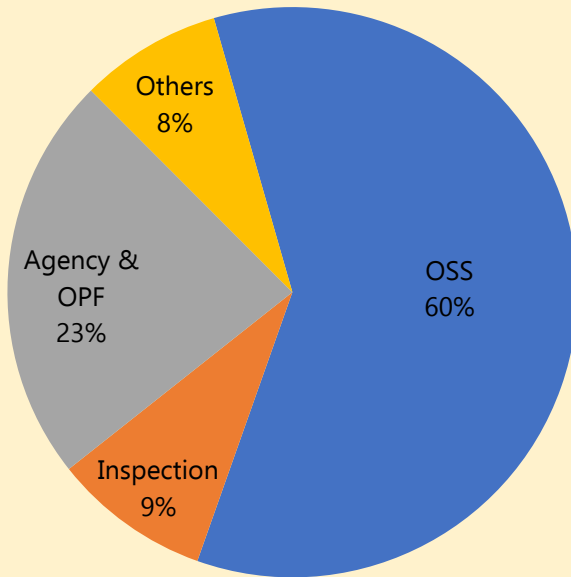
Remarks:

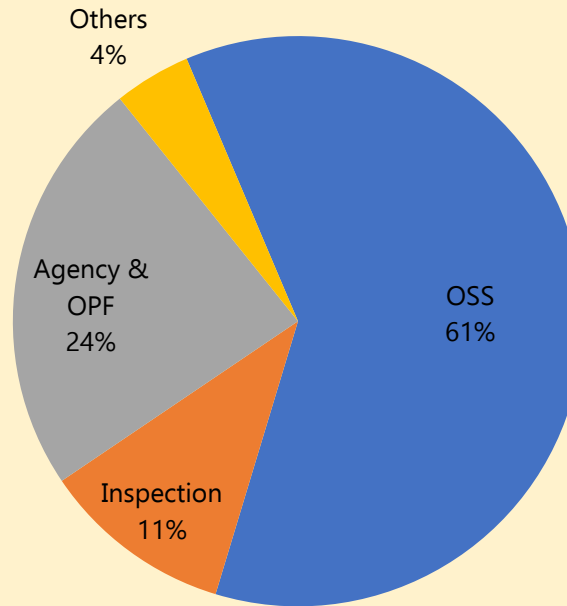

H1 2023



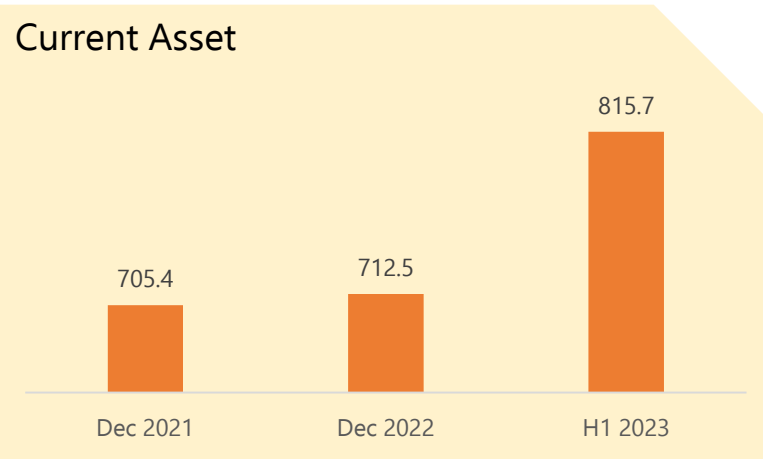
Remarks:

- Lower revenue from "other" segment due to decrease in Construction sector.

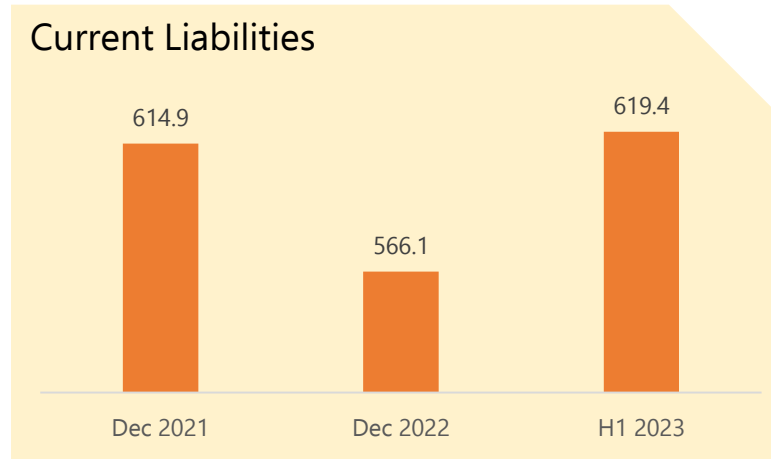

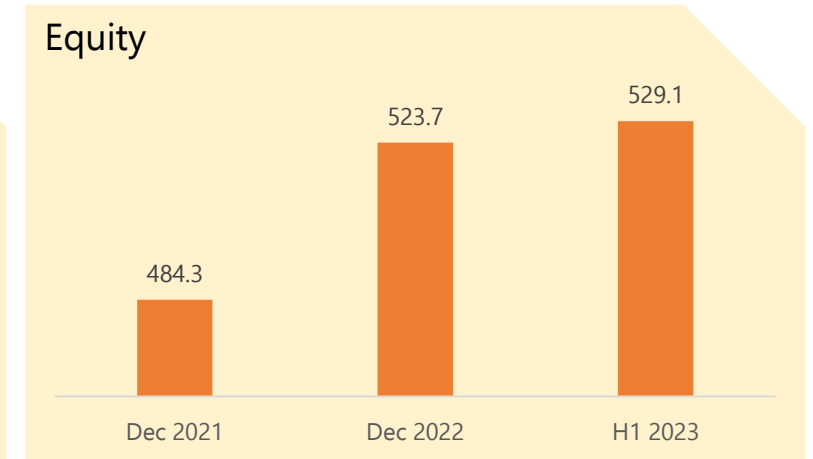

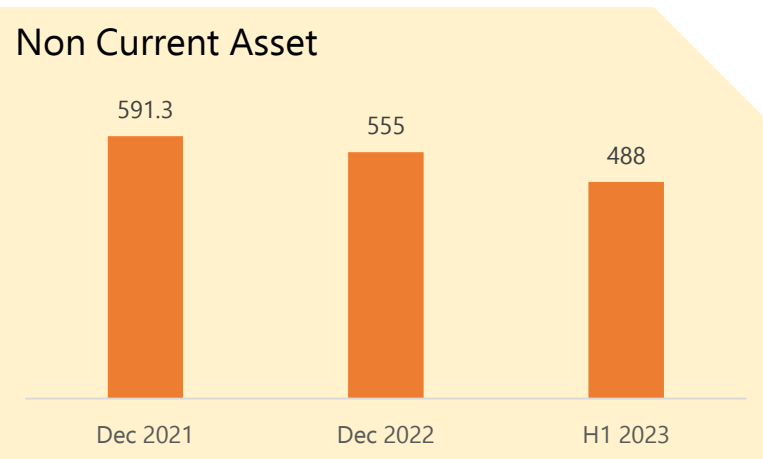

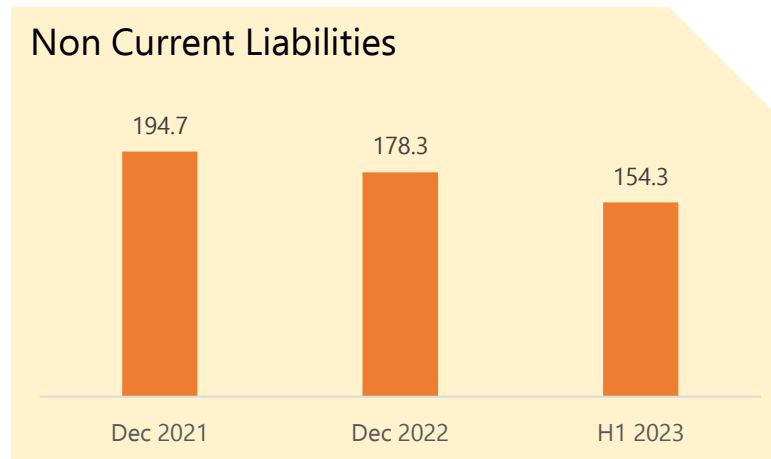
